

New England Nor'easters The Finals

We headed into the finals with an unprecedented 11-1 record. We faced the Miami Sharks, who had made a remarkable run after starting the season 0-3. The Sharks made it to the play-offs and then beat the Chicago Blaze and Arizona Scorpions to reach the finals.

The line-ups were as follows:

- Board One IM Sam Shankland (New England) – GM Julio Becerra (Miami)
- Board Two
 FM Marcel Martinez (Miami) IM Robert Hungaski (New England)
- Board Three FM Chris Chase (New England) – FM Charles Galofre (Miami)
- Board Four
 Nicholas Rosenthal (Miami) NM Alex Cherniack (New England)

We played the same line-up as we did in the first two rounds of the play-offs. Oddly enough, we used ten different line-ups in the ten weeks of the regular season, and the same line-up for every round of the play-offs, which (funnily enough) was the only line-up that did not win in the regular season! We had many possibilities, but we decided to stick with the "hot hands."


Miami was led by the current and three-time MVP, Julio Becerra. They were, however, without GM Renier Gonzales. Martinez moved up a board and Galofre played (well, did not play) Board Three. Their fourth board was the young upstart Nicholas Rosenthal, who had already scored some noticeable upsets in the play-offs. The substitute of Galofre for Gonzales was obviously favourable for us, but as the astute reader knows, we relish our normal role as the underdog. Not this time.

This was a strange match. Thirty minutes went by, and Galofre had not shown up. Alex, who had been an absolute rock, was in all kinds of trouble against the lower-rated Rosenthal. Everything was fine on Boards One and Two, but it was still early. A little over thirty minutes into the match, the USCL commissioner called and said that Galofre was having car trouble. They could get him, but the only person available was Miami's TD. I was told that we would have to approve him leaving, which of course was fine. I know the Miami guys and was hardly worried about the lack of the TD. Unfortunately, they just could not get him there in time. So we got a forfeit win. We were not exactly happy about this – no one wants to win this way. It was just a bad situation. Now if we won the match $2\frac{1}{2}$ - $1\frac{1}{2}$, it would be the forfeit that decided the match.

Alex went down quickly, but Sam was pressing and Robert was doing well too – he even turned down a repetition of moves. I made my usual coffee run, and soon after we were wining on both boards. Thus we won the match 3-1, and won the USCL Championship in our very first season!

The whole forfeit thing was annoying, as this was not the way we planned on winning Still, we scored 2/3 on the boards that actually played, so we will not feel too badly about it. And as we won on both Boards One and Two, I certainly believe that we won the match.
